

Statement of Notifiable Matters

This document contains important information that you should know in relation to the disclosure by Indue Ltd ABN 97 087 822 464 (“**we, us, our**”) of your personal information to credit reporting bodies. This applies to you if:

- you, as an individual (for example, as a sole trader or as a member of a partnership), apply to us for a facility; or
- we deal with you as a potential guarantor in relation to an entity (for example, a corporation of which you are a director) that applies to us for a facility.

As part of your application or the relevant entity’s application (as the case may be), we collect your personal information for the purpose of disclosing it to a credit reporting body. We do this in order to request from the credit reporting body a credit report that may contain personal and/or commercial credit-related information about you. In these circumstances, we disclose your information to the following credit reporting body:

In addition to disclosing your identification information, we may disclose to the credit reporting body the fact that you are dealing with us for a commercial credit-related purpose. This may be included by the credit reporting body in reports it provides to other credit providers to assist those other providers’ assessments into your credit worthiness. We are not a consumer credit provider and we do not disclose any consumer credit information to credit reporting bodies.

Management of Credit-related Personal Information

You may use the credit reporting body’s contact details above to obtain a copy of its policy in relation its management of credit-related personal information. It is required to publish its privacy policy on its website.

Your rights

Credit providers may have the right in some circumstances to use a credit reporting body to assist them to determine if you are eligible for certain direct marketing offers from the credit provider. We generally do not use credit reporting bodies for this purpose. In any case, you have the right to contact credit reporting bodies, such as the one above, to request that they do not use your information for that purpose.

You also have the right to request the credit reporting body not to use or disclose credit reporting information about you if you believe on reasonable grounds that you have been, or are likely to be, a victim of fraud.

Access, Correction and Complaints

You have the right to request access to personal information (including credit-related personal information) we hold about you. You also have the right to request correction of that information and to make a complaint in relation to our handling of personal information, including where you believe we have breached a provision of the Privacy Act or an applicable code (such as the Credit Reporting Privacy Code).
